#### Session Overview

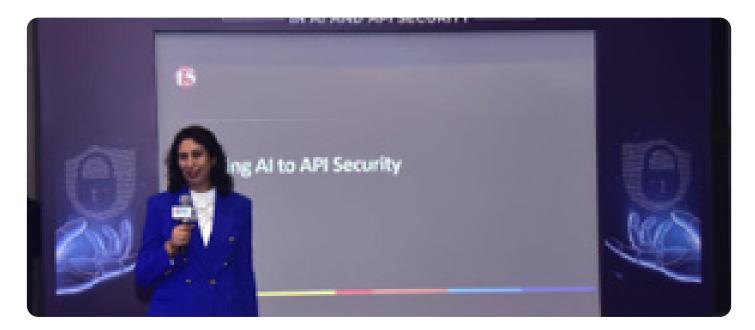
